The position, based in Brisbane, will provide a high level of professional services to the Agribusiness division on a range of finance related matters to achieve improved practice financial analysis and reporting objectives, while ensuring a strong customer focus through the provision of high quality financial advice.

The ability to partner with a diverse range of stakeholders across all levels of the organisation is critical to the success of this role. This role will work closely with the Agribusiness team, providing advice, support and collaboration in a dynamic environment.
