About The Role

The Manager Practice and Development is responsible for the oversight of the BWAHS practitioners and management of all therapeutic activities.

The successful candidate will have demonstrated management and leadership skills, including the ability to build a team and team members to perform well. You will have experience providing clinical supervision, monitoring workloads and individual performance as well as the ability to provide secondary consultation and advice to clinical staff and other professionals.

The Manager Practice and Development will work collaboratively with the Operations Manager to build and develop a skilled workforce, strengthen case practice, provide high quality effective service delivery and support other practitioners in the development of plans to bring about the changes necessary to ensure the safety, stability and development of Aboriginal children, young people and their families and to achieve case plan objectives.

The position will have supervisory responsibility, commensurate with their other duties and will drive practice excellence throughout the organisation, offering guidance on these matters to the Board.

To be successful in this role, a tertiary qualification in Psychology, Social Work, Family Therapy, Child Psychotherapy or related discipline is required. A minimum of 5-7 years' experience conducting clinical work and 3-5 years' experience in supervising clinical staff is also required.
