Nearest Town: Shute Harbour is in sheltered port for small vessels located approximately 10 kilometres east of Airlie Beach.

Other identifiable features: The site is located in and adjoining the Whitsunday Shire - at Shute Harbour Road, Shute Harbour. It lies outside the boundary of the Great Barrier Reef Marine Park (GBRMP), Dugong Protection Areas and Fish Habitat Areas (FHA). Part of the site is within the Great Barrier Reef World Heritage Area.
