

Southern West Yiradyuri

The proposed native title determination application area (above map) is in NSW only. It is bounded approximately by Bland Creek in the northeast, the Lachlan River in the northwest, Billabong Creek and the Murray River in the south, Mount Ulandra in the east, and the junction of the Murrumbidgee and Lachlan Rivers in the west. The Murrumbidgee River runs from east-to-west through the centre of the application area.

Purpose of Authorisation meeting:

The purpose of this meeting is to consider, and if appropriate, make decisions about the following:

- 1. Discuss and confirm the process of decision making for the purpose of authorising a person or persons to make the native title determination application and deal with matters arising in relation to it.
- 2. Consider and authorise a native title determination application on behalf of the proposed native title claim group, over the lands and waters, marked on the map above.
- Authorise one or more members of the proposed native title claim group to make the native title determination application, and to deal with matters arising in relation to it:
 - a. The proposed native title claim group will consider resolutions and make decisions to authorise an Applicant(s) to make the native title determination application and deal with matters arising in relation to it.
 - b. The proposed native title claim group will be asked to consider resolutions and make decisions about placing conditions on the powers of the Applicant(s). For example, the Applicant's ability to enter into commercial and other agreements which may affect native title rights and interests.
 - c. The proposed native title claim group will be asked to consider and make decisions about the processes the Applicant(s) must undertake to make decisions. For example, whether or not the Applicant(s) can make decisions by majority.
- 4. Authorise the native title rights and interests to be claimed under the proposed application.


