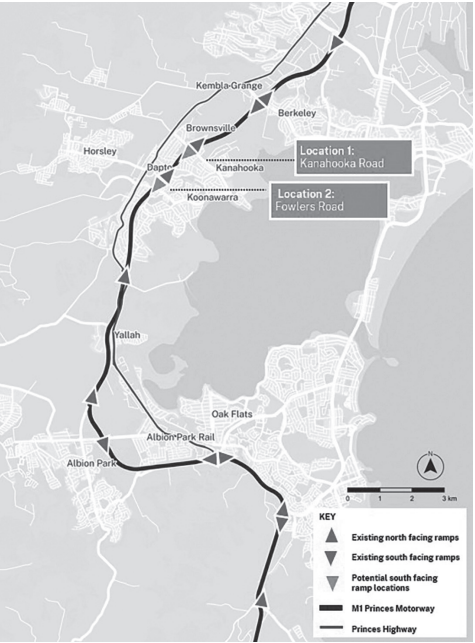

South facing ramps at Dapto

Transport for NSW (Transport) invites Aboriginal people and Aboriginal groups who hold cultural knowledge relevant to determining the significance of Aboriginal objects and places for South facing ramps at Dapto project to register to be consulted.

Planning is under way for additional entry and exit ramps on the M1 Princes Motorway to improve connectivity for motorists in Dapto and the surrounding suburbs. The new south facing ramps aim to improve access to the Motorway and reduce the distance and time residents of Dapto and neighbouring suburbs must travel to access the motorway.

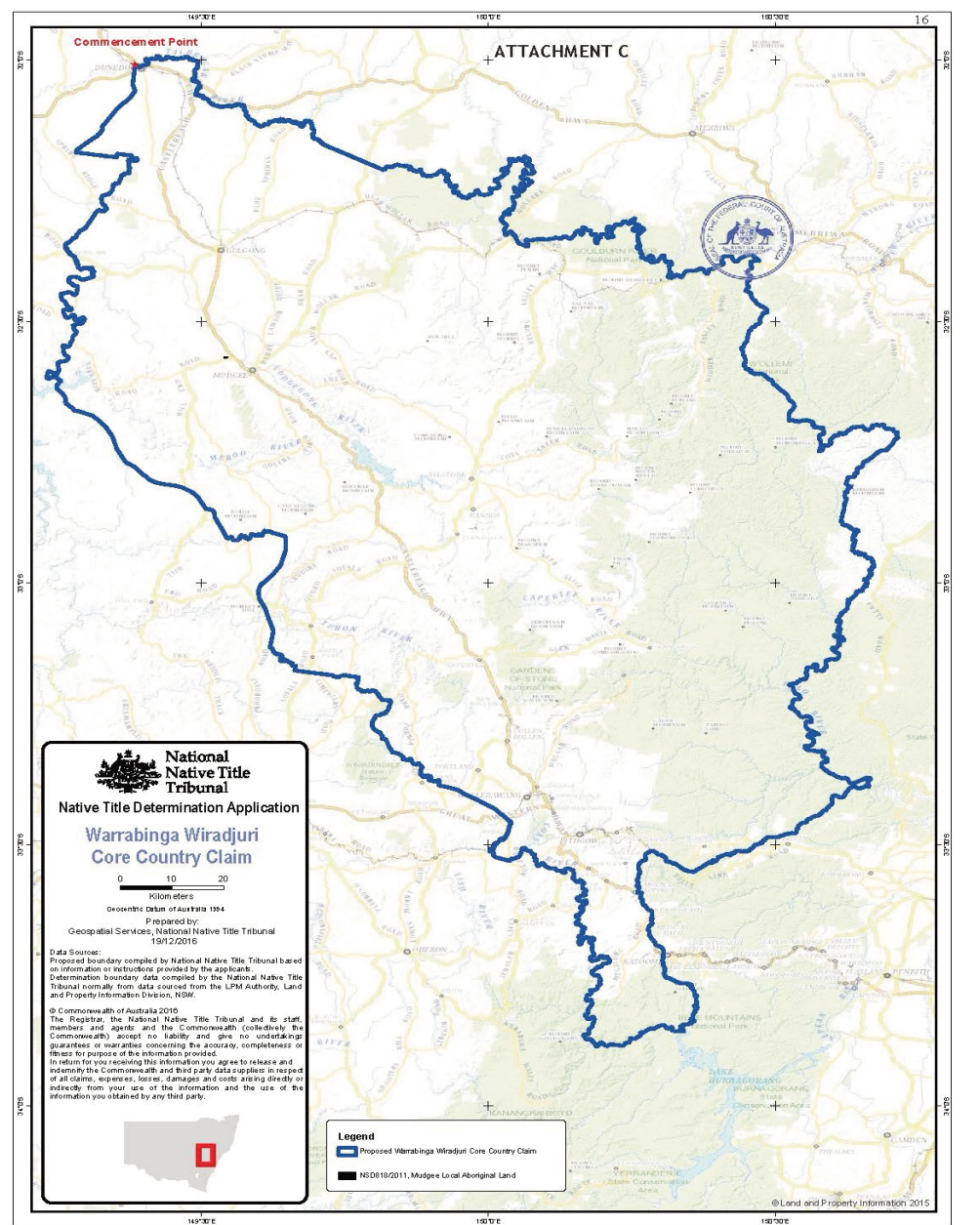

All parties are advised that the Sponsor may elect not to endorse an Aboriginal Party that has not received a written notice within the required time.
