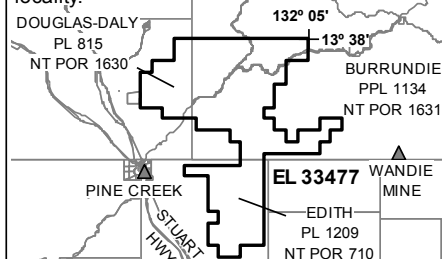

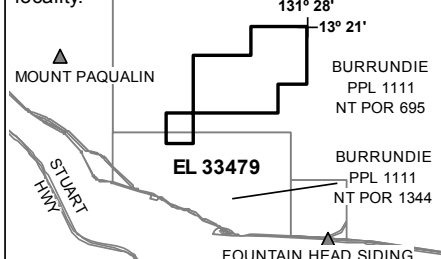

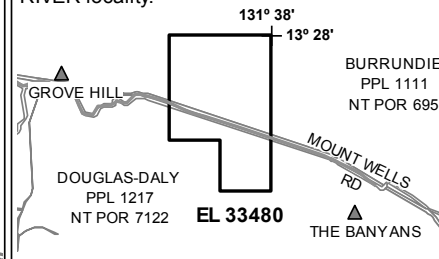

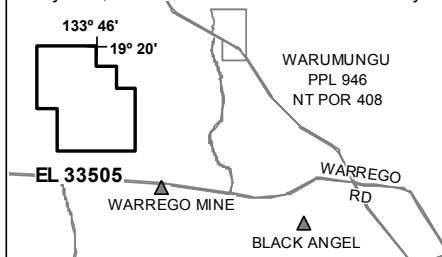

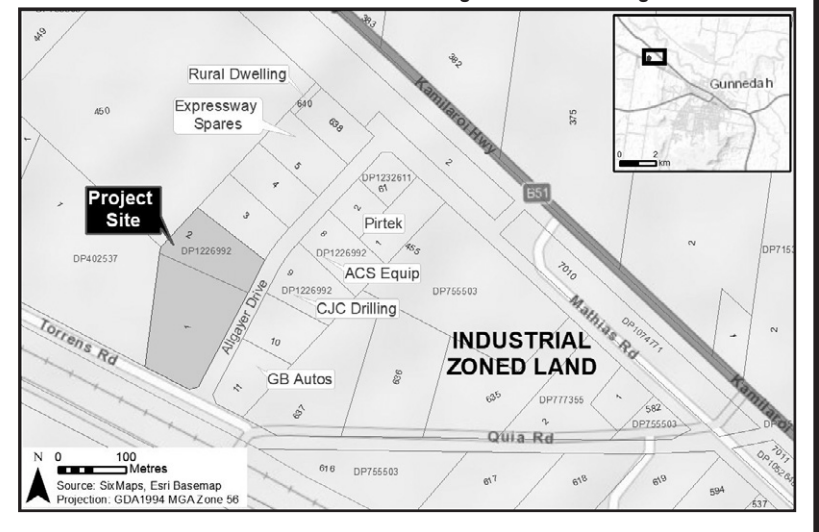

Figure 1: Plan Showing Area of Interest

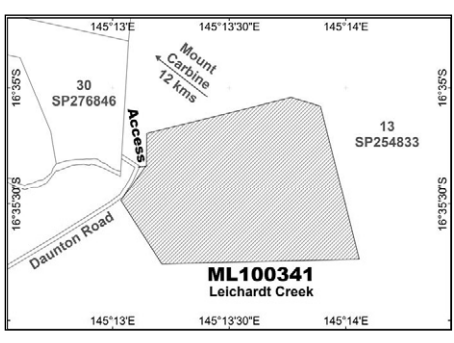

FIRST MEETING – DJABUGAY NATION (QUD692/2016)

PERSONS ELIGIBLE TO ATTEND:

The persons eligible and invited to attend the first meeting are the members of the **Djabugay Nation claim group** as described in their native title claim QUD692/2016. The Djabugay Nation claim group are the Djabugay-Yirrganydji-Bulway-Nyakali-Guluy People and comprise the persons descended (including through traditional adoption and from patrilineal / father's line or matrilineal / mother's line) from one or more of 53 Djabugay Nation Apical Ancestors. The purpose of the first meeting is for NQLC to provide information about the proposal for the Yirrganydji (Irukandji) claims to be unified with the Djabugay Nation claim. Djabugay Nation claim group members will be given an opportunity to acknowledge their respect for Djabugay-Yirrganydji-Bulway-Nyakali-Guluy ancestors, family groups and tribal clan groups who have united to seek native title determinations, and to also discuss that any corporation determined to be the Djabugay Nation prescribed body corporate is to include rules to ensure that the directors will be representative of each of the Djabugay, Yirrganydji, Bulway, Nyakali and Guluy groups.

PURPOSE:

The purpose of the second meeting is for the Yirrganydji (Irukandji) People claim group to discuss, consider and make decisions about amending the Yirrganydji claims so that the description of the claim group for the Yirrganydji claims aligns with the description of the Djabugay Nation claim group.

For clarity, NQLC advises that the proposed amendment of the claim group description for the Yirrganydji claims to become native title claims for the Djabugay Nation claim group will include all persons descended from the 11 apical ancestors listed above, all of whom are named as Apical Ancestors for the Djabugay Nation claim group.

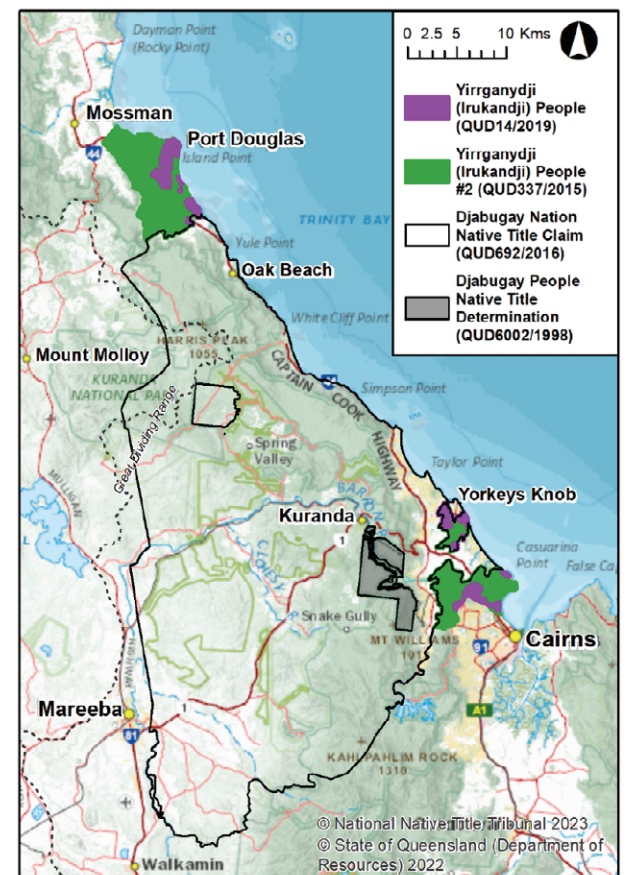
PERSONS ELIGIBLE TO ATTEND:

The persons eligible and invited to attend the third meeting are the members of the Djabugay Nation claim group. The Djabugay Nation claim group comprises the persons descended (including through traditional adoption and from patrilineal / father's line or matrilineal / mother's line) from one or more of the 53 Djabugay Nation Apical Ancestors.

PURPOSE:

If the Yirrganydji (Irukandji) People claim group members authorise the amendment of the Yirrganydji claims so that the description of the claim group for the Yirrganydji claims aligns with the description of the claim group for the Djabugay Nation (QUD692/2016) native title claim, the purpose of the third meeting will be for the members of the Djabugay Nation claim group to discuss, consider and make decisions about:

1. Approving the amendment of the claim group description of the Yirrganydji claims so that it aligns with the description of the claim group for their Djabugay Nation (QUD692/2016) native title claim.
2. Authorising the replacement of the applicant for the Yirrganydji claims (Jeanette Singleton, Kerri Sheppard and George Skeene) with the Djabugay Nation applicant (Bruce Banning, Alfred Gray Jnr, Richard Bing Jnr, Florince Williams, Sydney Gray, Dianne Ambrym, Raymond Franks, Kathleen Lakatos, William Brim, Astro Brim, Earl Hobbler, George Singleton, Gavin Singleton Jnr and Mercy Baird) pursuant to s.66B of the Native Title Act.
3. Placing conditions on the authority of the replacement applicant pursuant to s.251BA of the Native Title Act.
4. Authorising the North Queensland Land Council to be appointed as the legal representative for the applicant to the Yirrganydji claims.
5. Authorising the change of the name of the Yirrganydji claims to "Djabugay Nation" and / or for the Yirrganydji claims to be combined with the Djabugay Nation claim and / or for all three claims to be conducted as one proceeding in the Federal Court.
6. Such other matters that may be required to give effect to



decisions made in relation to items 1 to 5 above and also to give effect to decisions from the first and second meetings.

The Iman PBC intends that the interim payment will be into the Iman People's Native Title Charitable Trust.

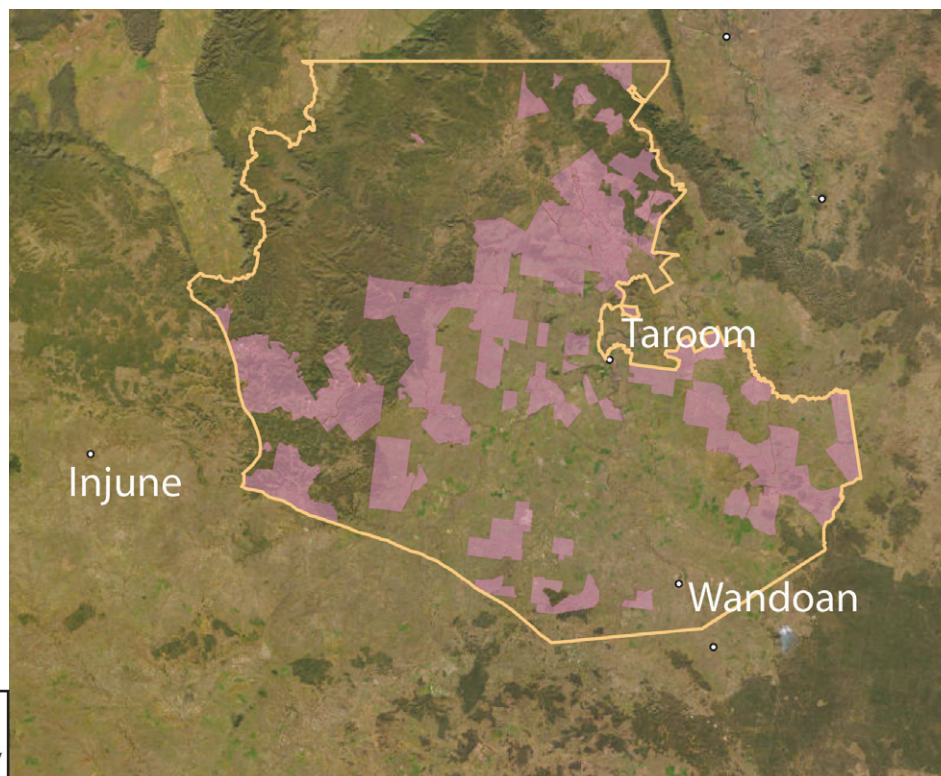
If authorised, the ILUA will bind all Iman Native Title Holders in respect to the amount of the interim payment.

Representatives from the Native Title Compensation Unit of the State Government and the Iman Native Title Lawyer will be on hand to report and answer your questions.

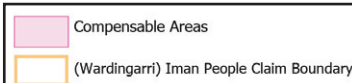
