### About the Early Childhood Education and Schools Policy Directorate

Early Childhood Education and Schools Policy is part of the Education and Skills Reform (ESR) division. We drive strategic policy and deliver innovative solutions which improve educational outcomes for children and young people in early years settings and across all NSW schools. We have teams leading early childhood policy, programs and transformational change, as well as teams undertaking schools policy for government and non-government schools, and compliance of non-government schools with the requirements of the not-for-profit provisions of the Education Act NSW.

Our schooling policy teams are committed to achieving the Department's priorities of high-quality and equitable education provision, so that every student is known, valued and cared for, and every student's learning improves every year. We undertake analysis of complex educational issues and take a consultative approach to developing evidence-informed policy solutions to respond to and anticipate current and emerging challenges. We work cross-sectorally, and support needs-based funding for nongovernment schools.

Our early childhood education teams are committed to driving educational and developmental outcomes for children attending education and care services, with the aim that all children in NSW participate in high quality education and care. Our work is based on established evidence of the benefits of early childhood education to enhance children's cognitive abilities and social and emotional skills. We carry out research and analysis on how to effect positive educational change particularly for Aboriginal children, children with disability and children in regional and remote NSW. We also directly fund early childhood education services and organisations to help meet the goals of the National Preschool Reform Agreement, and to support services to deliver high quality education and care.
