### **Duties**

Digital Services is part of the AIATSIS Strategy and Operations Group.

Digital Services provides the network infrastructure, Standard Operating Environment, servers, virtual machines and data storage capabilities for AIATSIS, including the provision of telephones, computers and associated data and software applications within the Organisation. It is responsible for ICT security in accordance with Australian Government legislation and requirements.

The Infrastructure and Security Manager leads a small team of ICT Infrastructure specialists in maintaining a robust and secure network, information systems and operating environment. The Manager serves a lead role in delivering a Technology Refresh Program and Security Uplift Program for the Institute which aim to refresh, modernise and uplift capability which supports the Institute in delivering core programs and functions.

The position reports to the Chief Information Officer (CIO) and Deputy Chief Information Officer (DCIO).
