We currently have an exciting opportunity for a Casual Room Service/ Food Services Facilitator in our Food Services Department.

In the Facilitator role, serves as the 'lead' service person verifying tray accuracy and prompt delivery. The Facilitator must have a demonstrated familiarity with food operations and a working knowledge of patient diets.

This position is responsible to maintain a clean, safe, sanitary work environment. This position functions as part of a team that ensures delivery of food to patients within 45 minutes of the order being placed.

The Facilitator will also be responsible for assigning the starter/mid facilitator to perform meal tray sweeps to pick up dirty patient tray trolleys from the soiled utility rooms on the floors as appropriate, during quieter periods. The Facilitator acts a "team leader" because he/she regulates the flow of trays and the speed of the cooks' side and to create a smoothly flowing workload balance.

- Good understanding of Food safety and HACCP procedures Good organizational and time management skills
- Able to work in a busy fast paced environment
- Excellent skills in using Microsoft Excel and Microsoft Word
- Good understanding of hospital operations
