



## VX GUIDE | PART TIME FIXED TERM

ACMI is the museum of screen culture. Navigate the universe of film, TV, videogames and art with us. ACMI celebrates the wonder and power of the world's most democratic artform – fostering the next generation of makers, players and watchers. ACMI's vibrant calendar of exhibitions, screenings, commissions, festivals, and industry and education programs explore the stories, technologies and artists that create our shared screen culture.

In June 2022, ACMI will open *Light: Works from Tate's Collection*, an exhibition curated by Tate in the UK and drawn from their prestigious collection. *Light* brings opportunities for you to join the VX team on a part time, fixed term basis (41 hours/fortnight, 16 June 2022 - 13 November 2022). Reporting to a team of VX Supervisors, the role is responsible for gallery invigilation, the delivery of talks, tours and introductions to visiting groups as required, and the provision of a consistently exceptional visitor experience. VX Guides may also be required to work in other areas of Visitor Experience operations.

Our ideal team member will have experience in delivering high quality customer service within a museum/gallery context, with a focus on front of house operations. You will have strong communication and interpersonal skills, with the ability to engage visitors by presenting a working knowledge of exhibition concepts to enhance their experience. If you are a motivated team player, who thrives in an environment of high visitor volumes, then this is the role for you.

If successful, you can expect to become part of a talented, committed and creative team of people with a passion for screen culture. This Grade 2 role is offered on a fixed term, part time basis (41 hours/fortnight, 16 June 2022 - 13 November 2022), with a starting salary of \$55,439 pro rata plus super. As part of the Visitor Experience team, you will work according to a fortnightly roster, which may include weekend and evening work. A current Victorian Working with Children Check is required.
